

**ELECTION LEGAL NOTICE
NOVEMBER 5, 2019**

To the Electors of Larimer County:

Pursuant to Colorado Revised Statutes, Section 1-5-205, notice is hereby given that a Coordinated Election will be held on Tuesday, November 5, 2019, between the hours of 7 AM and 7 PM.

The election will be conducted as a mail ballot election. A mail ballot, return envelope, and voting instructions will be mailed to every active voter in Larimer County during the week of October 14, 2019. You may return your voted ballot by mail with adequate postage (postage is 55 cents) or you may hand deliver your ballot to a designated 24 hour ballot drop box, grocery store ballot drop-off location or a Voter Service and Polling Center.

24 HOUR BALLOT DROP BOX LOCATIONS (open October 11 – November 5)

Voters may drop off their voted ballots 24 hours a day at the following ballot drop box locations. Ballots will be accepted in these boxes until 7 PM Election Night:

All ballots must be received by the County Clerk & Recorder by 7 PM on Election Day, Tuesday, November 5, 2019.
Postmarks do not count as a received date.
