BHPC Chair & Vice-Chair Duties

- 1) Chair
 - a) The Chair shall be principal executive officer of the Behavioral Health Policy Council and as such, shall, when present, preside at all meetings of the BHPC.
 - i) Duties to preside shall include, ensuring a quorum to start meetings, lead discussions and decisions made by the Council as well as submit motions for review.
 - b) The Chair shall have the same right as any other member of the Council to vote on motions before the Council and speak for or against them.
 - c) The Chair shall provide information and input for the preparation of the agenda for BHPC meetings.
 - d) The Chair shall act as the official spokesperson for the Council and enforce all by-laws.
 - e) The Chair shall sign all documents approved by the BHPC, when necessary.
 - f) The Chair may represent the Council's interest in transactions with the Larimer Board of County Commissioners.
 - g) The Chair shall assign and delegate any such responsibilities as needed.
 - h) In general, the Chair shall perform all duties incident to office and such other duties as may be prescribed by a majority of the members of the BHPC, within the Council's authority.
- 2) Vice-Chair
 - a) The Vice-Chair shall have the power to perform all of the duties of the Chair In the absence of the Chair or his/her incapacity.
 - b) The Vice-Chair shall perform such duties as, from time to time, may be assigned by the Chair, or by a majority of the BHPC, within the Council's authority.
- 3) Chair Pro-tem
 - a) In the absence of the Chair and Vice-Chair, another member present at the meeting can be nominated to preside at the meeting and exercise all the duties of the chair.

BHPC Chair & Vice-Chair Nomination/Appointment

Nomination and Appointment Process

Chair and Vice-Chair positions will be reviewed and affirmed/appointed at the first meeting of each year. Terms for Chair and Vice-Chair will last for 1 year. No person shall act as Chair or Vice-Chair for more than 2 consecutive years.

To determine the positions, any voting member of the Council/Committee can make a motion to nominate another member (or themselves) at which point it will have to be accepted by the nominee and seconded by another voting member.

After all motions to make a nomination are made, the Council/Committee will vote for the nominations of each position and each voting member will have 1 vote for each position, the nominee with the most votes per position will then be appointed to their nominated position.

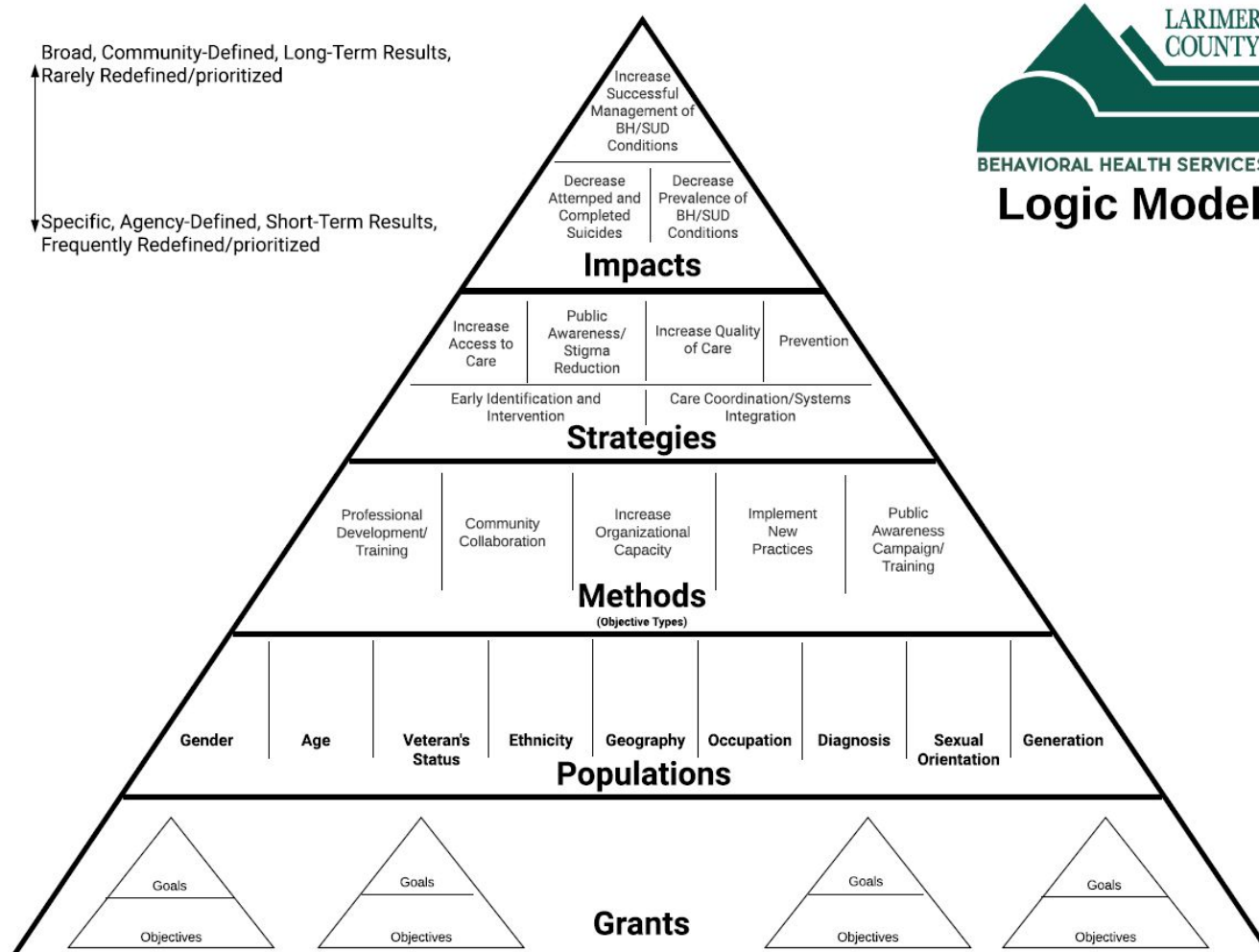

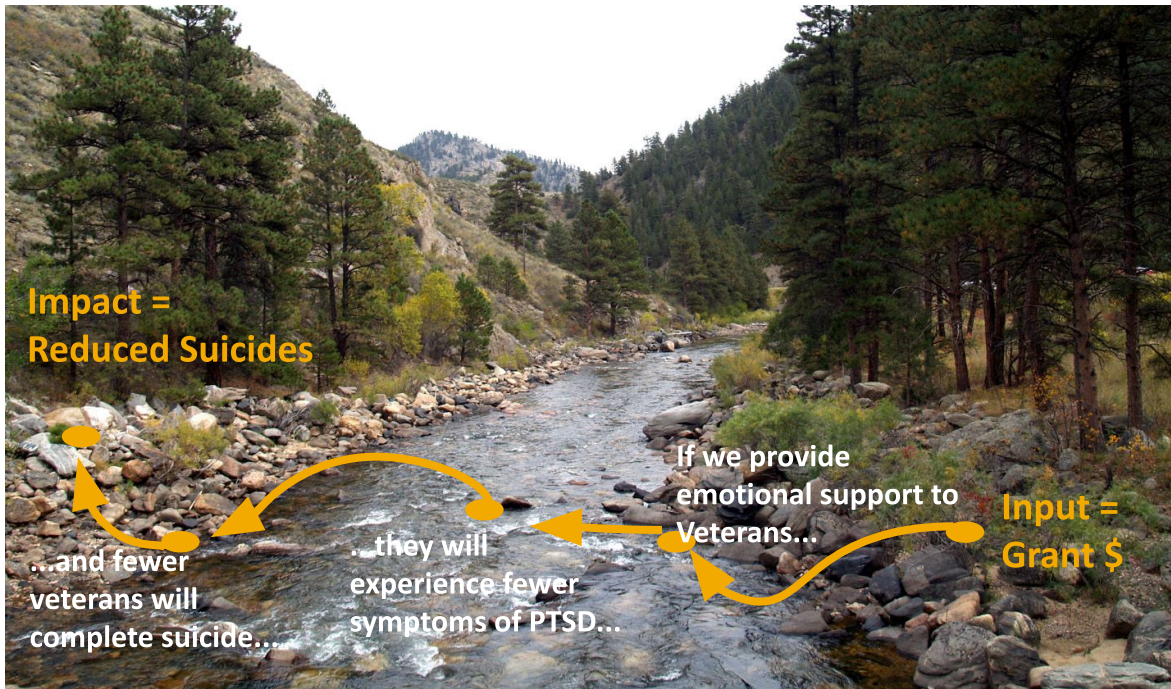
BHS Logic Model



BHPC Dashboard

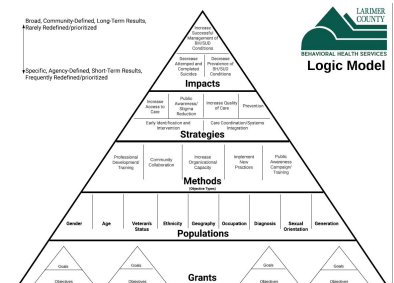
Impact
