# **Board Member Appointment**

# **Budget:**

Mr. Behunin presented the 2022 budget.

### **Education Plan**

Results from the previous employee survey around education were considered. Board is interested in making education more useful to participants, thus Jeff Metcalfe from TIAA will look





to attend upcoming department head meeting April 8, 2022. TIAA presented monthly webinar series that are available to participants.

#### **Plan Restatement**

TIAA provided an update on the status of the Plan Restatement. Board approved to accept the restated plan document as it was presented.

# **Capital Market & Investment Report from Innovest:**

Ms. Soto and Mr. Martin reviewed Q4 2021 plan activity, economic data, and plan investments, noting existing minor performance concerns for the T. Rowe Price Mid Cap Growth and TIAA Real Estate, as well as a new minor concern for T. Rowe Price Blue Chip Growth for people as one of the portfolio managers has retired. All funds have an overall score of no concerns and no recommendations for these funds. As a result of the existing major performance concerns for the two international equity funds Templeton Foreign and AQR International Equity, Innovest presented recommendations for alternative international options, plus the addition of a passive international equity index fund.

#### **International Funds Investment Review:**

Mr. Martin presented manager search options for International Value equity and international growth equity options, as well a manager option for a passive international stock index. The Board approved the change from Templeton Foreign (FTFGX) with Dodge & Cox International (DODFX). The Board approved the addition of the passive international equity option of Vanguard Total International Stock Index (VTIAX). Lastly the Board discussed the replacement of AQR International, the Plan's international growth equity option. The Board requested to see additional recommendations and would hold a special meeting to complete this discussion and make a final decision. The approved changes above, will be held until a decision is made, so that all changes can be implemented simultaneously.

#### **Plan Document**

TIAA discussed the upcoming SECURE Act 2.0 and the potential effects on the Plan and will continue to provide updates at future meetings.

# **Future Meeting Schedule**

The next meetings were scheduled for May 13<sup>th</sup>, August 12<sup>th</sup>, and November 18<sup>th</sup> in 2022, each at 10a.m. Future meetings are nonetheless subject to rescheduling as necessary.
