Market Days for Older Adults provides fresh produce to older adults experiencing food insecurity. A program of Larimer County Colorado State University Extension, all produce from Market Days comes from local farmers. Market Days began in 2019 and operates from June through October.





#### **VOUCHER PROGRAM RE-INTRODUCED**

Before COVID-19, participants received vouchers to shop at the Larimer County Farmers' Market. In September, we re-introduced the vouchers. Participants could choose between:

- A pre-made produce bag valued at \$18
- A voucher packet valued at \$18

CSU Service Learning Students were available at the Larimer County Farmers' Market to help shoppers. We distributed 114 voucher packets in September and October.
