Real Property Protests will be accepted May 1, 2025 through June 9, 2025.

The Notice of Determination will be mailed on August 15, 2025, C.R.S 39-5-122 (2)

All property owners may protest. Please note that submitting a protest initiates a review of the property value and may result in a higher valuation if warranted. Visit <a href="https://www.Larimer.gov/assessor">www.Larimer.gov/assessor</a> to submit your protest online or to schedule a phone or in-person appointment.

An **ONLINE PROTEST** typically takes less than fifteen minutes and includes an email confirmation that ensures that your protest was submitted prior to the deadline.

## PROTESTS VIA SCHEDULED PHONE OR IN-PERSON APPOINTMENT:

If you choose to present oral objections to the Assessor during a scheduled phone or in-person appointment, you may elect to complete & sign this form and deliver it to the Assessor's office at the address above. To preserve your right to protest, you must attend your scheduled phone or in-person appointment on or before June 9, 2025.

**PROTESTS BY MAIL:** If you choose to mail a written protest, you may elect to complete & sign this form and mail it to the Assessor at the address provided above. **To preserve your right to protest, your mailed protest must be postmarked no later than June 9, 2025.** Late protests will not be accepted.
