

ELECTION LEGAL NOTICE
November 3, 2026

To the Electors of Larimer County:

Pursuant to Colorado Revised Statutes, Section 1-5-205, notice is hereby given that a General Election will be held on Tuesday, November 3, 2026, between the hours of 7 AM and 7 PM.

The election will be conducted as a mail ballot election. Every active voter in Larimer County will be mailed a ballot. The first day ballots can be mailed to voters is Friday, October 2, 2026. The last day to request a replacement ballot in the mail is Monday, October 26, 2026. Voted ballots may be returned by mail with adequate postage or may be hand-delivered to a designated 24-hour ballot drop box or a Voter Service and Polling Center.
