The Purchasers are desirous of proceeding with their acquisition of the Property, subject to the terms and conditions of this Agreement. LCDHE is desirous of permitting them to do so by issuance of a Conditional Transfer of Title Acceptance Document as described in 43.4.P.8 of the LCDHE Regulations, and subject to the following terms and conditions.

Now, therefore, in consideration of the above, the Purchasers agree as follows:

1. To apply for an OWTS Repair Permit as required by LCDHE to complete the repairs indicated by the inspection or to complete the required inspection that could not be completed due to weather, and pay all required application fees, within 180 days of the Closing Date listed above.

2. Purchasers acknowledge that any repairs, changes, alterations or replacements that require a permit may not be commenced until LCDHE issues the appropriate permit, following receipt of Purchasers' application.

3. Purchasers acknowledge and agree that Purchasers' failure to comply with the terms of this Agreement will cause LCDHE to initiate enforcement actions against Purchaser, in accordance with LCDHE regulations.

4. The terms and conditions of this Agreement shall be null and void in the event that Purchasers do not complete the acquisition of title to the Property.
