Livestock Sale 2020 FACTS:

- 227 youth enrolled in Livestock Market Projects (Goat, Sheep, Swine and Beef)
- Of those 89 are in Swine of those 89 (9) also have a Sheep, (5) have a Goat and (5) have a Beef
- 50 youth have a Beef
- 66 youth have a Sheep of those (5) also have Beef and (4) have a Goat
- 54 youth have a Goat
- Per Livestock Sale Committee requirements as printed in the premium book "All animals must be shown at the 2020 Larimer County Fair and only those animals eligible from market classes will be able to sell."
- Exhibitors can sell only one animal in this sale

Centennial Livestock Auction (CLA)

- Ability to house animals goats/sheep would have to arrive Tuesday AM; Swine would have to arrive Wednesday AM. Beef would arrive Friday AM
- Buyers do not have to be present as CLA offers online 4-H youth and family can watch sale online
- CLA has agreed to announce prior to animal entering ring that it is a 4-H animal
- CLA willing to work with Cheryl Spence during the sale to make sure buyers know it is a 4-H animal
- 4-H youth will get some recognition when animal being sold can announce those that are in their final year (this can also be noted in sale bill)
- Sale bill can be made electronic to distribute well in advance
- CLA will issue checks to participants appx one week following sale
- Food available
- CLA will sort animals after sold for custom packers and processors as needed
- Sale committee will only have limited paperwork to be responsible for
- Add-Ons will be as always before, during and allowed up to two weeks following sale
- Sale Committee only responsible for collecting Add-Ons
- There is no need to mail out paperwork ahead as CLA has their own that must be completed
- Current processors can work with CLA (food bank is on board)
- Brand Inspectors present
- Location of CLA
- Sale committee would only need a limited number of volunteers

- Sale committee would have to be present when 4-H animals arrive to verify
- Any required paperwork would have to be submitted ahead of arrival
- Sale committee responsible for tagging animals except beef
- Buyers would have to register on CLA website at least one week prior to sale
- Animals sold by species in no particular order
- Limited seating only buyers to be present no 4-H youth or families is requested
- CLA will weigh animals for accurate weights
- The potential that a youth may only get market price
- If use CLA facilities for private sale on Tuesday it will cost to pay CLA staff and the potential a youth may not sell
- If Sale held during regular CLA sale and intermixed there is no extra charge other than the commission
- Youth will be required to pay a 2-3% commission to cover costs
- Sale split into two days Beef sold on Friday
- Sale Committee is responsible for handling animals going to custom packers
- Sale Committee will still have to enter results into Blue Ribbon program
- Buyers must pay at conclusion of sale unless they make arrangements with CLA
- 4-H youth will not be permitted to bring their own animals into sale ring
- Sale Committee will put a sale bill together listing 4-H youth, parent name and species being sold so buyers can have ahead of time to review
- Non-Terminal the sale committee cannot guarantee that a 4-H animal goes to a processor
- No selling of the small animals sale committee would have to prearrange buyers for those participants
