



1B.3	Frontline essential workers and people age 16-64 with two or more high risk conditions:	» Frontline essential workers in food and agriculture, manufacturing, U.S.postal service, public transit and specialized transportation staff, grocery, public health, frontline essential human service workers, faith leaders, and direct care providers for Coloradans experiencing homelessness and essential frontline journalists.	» People 16-64 with 2 or more high risk conditions as listed: Coloradans with cancer (defined as patients who are currently receiving treatment or have received treatment within the last month for cancer), chronic kidney disease, COPD, diabetes mellitus, Down syndrome, specific heart conditions (heart failure, cardiomyopathies or coronary heart disease, and severe valvular/congenital heart disease), obesity (BMI ≥ 30kg/m^2), pregnancy, sickle cell disease, solid organ transplant and people with disabilities that prevent them from wearing masks.



28,483 have had at least one dose






## Long Term Care Facilities

- All 54 of our enrolled long term care facilities have completed at least one dose of vaccine at this time.
- Cases in long term care facilities are down 58% since their peak on January 17 while cases overall are down 31% from the same day.


