## Operator Registration Submittal Requirements

Operators with existing oil and gas facilities in Larimer County prior to the effective date of this article will submit the Annual Operator Registration submittal requirement within 90 days after the effective date (September 15, 2021) of Article 11.0.; or, if not already operating wells in Larimer County, within 60 days after assuming responsibly for operating existing oil and gas facilities.

Operator registrations must be updated and renewed annually by July 1.
