### 6. UPDATES & REPORTS

- a. Staff are in the process of clearing snow from last weekend with several sites closed due to muddy conditions. Big T. Canyon parks reopen April 1<sup>st</sup>, weather permitting. Seasonal staff are being hired across the department. Newly replaced webcams are in place at Horsetooth Mountain and Devil's Backbone Open Spaces which allow the public to check parking lot/trail capacity conditions prior to arriving.

    - i. The CIP review will be provided at the May meeting.

#### 8. ACTION ITEMS

- a. CDOT Big Thompson Canyon Parcels Final Review
  - i. Both action items (CDOT and Yeager parcels) are part of a long-term post-flood effort to expand and fill gaps in county ownership in the Cedar Cove and Forks Park areas of the Big Thompson River. The terms of the agreement provided CDOT to use portions of county parcels adjacent to Hwy 34 in the post-flood rebuild in exchange for parcels that build upon our existing land ownerships. Overall, the value difference in this exchange requires Larimer County to pay \$10,192.85 to CDOT for three parcels.
- b. Yeager Final Review
  - i. Two parcels totaling 0.27-ac to be acquired from the Yeager family will contribute to part of the county's goal of conserving a continuous block of land within Cedar Cove for a purchase price of \$10,000.
- c. Bob moved to recommend the approval of both projects to the BOCC, Pete seconded, motion passed unanimously.
- 9. OTHER BUSINESS
  - a. Commissioner Shadduck-McNally provided an update that the BOCC is attending National Association of Counties meetings to determine how to use Rescue Act funds to support Larimer County, including DNR. We are home to the state's only mass vaccination site in partnership with FEMA, located at the Ranch Events Complex. Daylan has been providing department information at work sessions with plans to discuss fee structure and budget considerations on Monday.
