



Vision: We believe that no one should become homeless for lack of access to housing justice.





- Weekly legal clinic Thursdays & Fridays at Denver County Court








Serving Larimer County

- Legal support and representation in all aspects of landlord-tenant law
- Community engagement and education
- Mobile Home Initiative
- Filling the gap in legal services (no immigration status restrictions, relaxed income restrictions)


2022 Immediate Needs Grant

- Larimer County funds exhausted by October 31, 2022
- Provided legal support to 114 unduplicated households
 - 263 individuals based on household size
 - 39 self-reported as having a disability
 - 22 were Spanish-speaking
 - 44 were mobile home residents
- 532 residents attended educational programs or legal clinics
- 35 applicants were referred outside of CPLP: 12 due to capacity and 23 due to priority or eligibility



Larimer County 2023 estimates (January - April)

- Tenfold increase in applications from Larimer County
- 53 households provided with legal services (direct representation, technical assistance)
- 355 individuals attended educational clinics
- 94% of 2023 CPLP Larimer applicants served
