

# Alianza NORCO: Final Report for Larimer County Immediate Needs Grant

To the Staff of Larimer County,

Alianza NORCO would like to express our deep appreciation for the Immediate Needs Grant from Larimer County. This grant helped us continue our growth as a grassroots non-profit. In the past two years, we have expanded the scope of our services and we have seen a dramatic increase in the number of clients we can assist. Our staff has grown from two members in 2021 to eight in 2023 and our operating budget has nearly quintupled. The Immediate Needs Grant was instrumental in this growth.

First, we would like to reintroduce ourselves to any reader who may not know of us. Alianza NORCO is a grassroots nonprofit founded and led by a Salvadoran immigrant with a majority immigrant team. Founded in 2017, our goal is to work in partnership with multi-ethnic allies and pro-immigrant groups to break down the obstacles we face as immigrants and empower our communities to change the systems that oppress us. Our mission is to strengthen our immigrant community members and their families through key services, resource navigation, community organization, civic education, and leadership development. We strive to affect change and advocate for immigrant rights at local, state, and national levels to increase immigrant safety, social cohesion, and civic engagement. Our approach to implementing direct service programs and community organizing centers on the voices of our immigrant community to create and provide service programs, policy, and processes. We provide immigration legal services, bilingual navigation services, civic education to increase immigrant engagement, and assistance for SB13-251 driver's licenses. These are complicated processes that many immigrants struggle with.

Historically, immigrants have suffered from lack of access to governmental and non-governmental services at the local, state and federal levels. In the last six years, immigrants faced worsening conditions as anti-immigrant sentiment swept across the country and we saw a devastating negative shift in international and domestic immigration policy. Three years ago, the COVID-19 pandemic began its rampage of infection across our immigrant population, many of

whom are essential frontline workers. Locally, the impacts of these two events were: reduced economic opportunities, worsening mental and physical health, decreased legal services, and a lack of upward mobility for our immigrant population.

The Larimer Immediate Needs Grant helped fund our Bilingual Navigation Program staff's work, primarily in the form of salary reimbursement. Our Navigation Program provides bilingual, culturally informed navigation to documented and undocumented people. We provide guidance for Colorado driver's licenses through the SB13-251 program, notary services, passport appointments, rent assistance, ITIN/tax preparation, and referrals for power of attorney forms and family law. All of these services are critical for our community members. The guidance that we provide for driver's licenses gives essential agricultural, construction, health aid and service workers access to reliable transportation and promotes safer drivers on our roads. During the height of the COVID pandemic, we adapted to provide virtual navigation to increase our undocumented community's access to COVID relief, providing direct grants and application assistance to over 400 immigrants. The pandemic exacerbated the already-fragile economy of many in our immigrant community. As of April 2023, we have four staff members working on our Navigation program with our Executive Direct program assisting and providing oversight on the program.

### **Numbers**

- a. In 2021 and 2022, our navigation team worked with over 965 clients. This number still takes us aback! We are proud of the number of clients we have guided, many of whom continue to spread the word about our services and get involved in our work;
- b. We were able to provide direct financial assistance to over 400 immigrants.

## **Community Events**

### Susana:

Susana is from Guatemala. During her journey to the US, her boyfriend was shot and killed. She eventually crossed the border but did not want to continue living. Years later, she was able to move on from that horrific experience. She married and had a miracle baby, her son, something she thought was medically impossible. Now living in Fort Collins, she was seeking safety and security when she contacted us to help with her driver's license, although this too was a battle. I helped her make unexpected payments for not having passed the written exam the first time and made additional appointments when she didn't understand why they had turned her away. Eventually we were successful, and she now confirms that having a license gives her day-to-day security when she drives her little son. Her family was also affected by the pandemic when she lost her old job and struggled to make ends meet.

This last year we met a single mom who was getting her license through our navigation services. During the process, our navigators found out that she was working three jobs to repair her water-damaged roof and kitchen, which was non-functional. Her children were struggling with school and mental health problems during the pandemic. We helped her with rent assistance, raised funds and organized our immigrant community to help repair her mobile home, connected her and her children to mental health resources, and helped obtain her driver's license. Our work transformed her life for the better and confirmed our commitment to bridging our community to other nonprofits.

"I am very grateful for the service that Alianza NORCO gave me and that they still continue to help me with the process of obtaining my driver's license. I don't feel very safe driving like this without a license, but when you have a family, you have to deal with it because you have no choice but to take risks and do it. But I know that when I have my license, this will make me feel safer driving on the streets and I will not be so afraid that a police officer will stop me and give me a ticket for driving without a license. This will also help me to reduce the cost of my insurance and the level of stress in which I live every day will be reduced a little more in my life."

We look forward to continued partnership with Larimer County as we work together to support and work alongside our immigrant community.
