#### Respite Care, Inc.

#### Mission Statement

Respite Care, Inc. is a nonprofit organization in Northern Colorado that provides shortterm, quality care for children with developmental disabilities and respite to their families, enabling them to enhance their quality of life.





#### History

Respite Care was founded in 1981

Started in a house on Wood & Cherry Streets in Fort Collins by a group of families that needed support and a community for their children with disabilities.

Moved to our current location 19 years ago





#### What We Do

- Specialized Care
- Serve Infants 18 y/o
- Pebbles, Rocks, Boulders
  - Medications, Seizure Management, Exceptional Child Care Staffing Ratio
  - Day Care for kids 0-5 y/o
- Overnight Care
- Before/After School Care
- Day Camp 8 weeks (including 2 weeks in Weld County)
- Wilderness Camp
- Horse Camp
- Enrichment Opportunities
  - Field Trips, Special Visitors, therapy dogs, music therapy, dance, art





#### **Immediate Needs Grant**

- Respite Care, Inc. implemented a cohorting system in order to continue operating and to reduce the risk of COVID-19 exposure.
- Many of our children are medically fragile so cohorting was a priority for us to stay open.
- Cohorting resulted in fewer children per classroom, requiring additional staff time and associated expenses.
- The Immediate Needs Grant from Larimer County funded these additional costs to enable our safe operation.







#### Impact of the Grant

Fully funded for \$68,995 to cover the additional costs of staffing during the covid pandemic.

RC was closed down from 03/16/2020 to 04/27/2020.

- Admin continued working from home, at full salary. Managed Covid response.
- Child care specialists had opportunities to be paid to clean the house, and were paid at a percentage of their average hours, to increase retention during and following the Pandemic.
- We didn't know when we'd reopen to families, but worked so that it could be as soon as possible, which required us to maintain staffing; a very small number of staff left due to the pandemic
- We hosted Distance Learning, which often required 1:1 staffing.
  We took on more: sanitizing, kids health checks, managing potential outbreaks, laundering PPE (masks) in house, managing vaccine opportunities for our staff, monitoring what is going on in the community, parent survey, etc.


#### Cohorting:

We provided two 4-hour blocks of care each day, from 8-12 and from 1-5. Staff cleaned between and after blocks. There was a limited amount of children allowed during each block to minimize contact. We separated groups and also staff who were permitted to work with each groups, much more stringently



#### Peace of Mind

Families have a resource in Respite Care that is difficult to find elsewhere.





#### **Enrichment**

Children who attend Respite Care have access to programs like Wilderness Camp and Summer Day Camp.





### Opportunity

Respite Care gives the gift of time to families; time to work, pursue educational opportunities, etc. while the kids are engaging in activities with their peers.

\*94% of families have indicated in recent surveys a decrease in stress levels due to Respite Care.



#### Respite Care Facts

- Our budget for the 23/24 Fiscal Year is \$2.3 million
- 854 volunteers provided over 5,800 hours
- 40 PT employees and 28 FT employees
- Provided over 52,000 hours of care
- Provided 169 nights of overnight care last year
- Sliding fee scale from \$3.50 \$13.00 an hour
  - Average family pays \$5.00 an hour
- Our cost to provide specialized care is \$33.50 an hour

15% Program Revenue




