<sup>3</sup>Penalty assessments will increase by \$250 for each subsequent civil penalty assessment up to a maximum of \$1000. The Department may allow the owner of an establishment to use any assessed penalty fee to pay for unpaid license fees, employee training, or the cost of needed improvements to the establishment.
