REVISIONS TO THE LARIMER COUNTY ON-SITE WASTEWATER TREATMENT SYSTEM REGULATIONS (OWTS)

WHEREAS, pursuant to Section 25-1-506(3), C.R.S., the Larimer County Board of Health ("Board of Health") has the power and the duty to initiate and carry out health programs consistent with state law that are necessary or desirable to protect public health and the environment; and

WHEREAS, pursuant to Section 25-1-508(5)(g), C.R.S., the Board of Health has the power and duty to adopt rules not inconsistent with the public health law of this state; and

WHEREAS, pursuant to Section 25-10-104(4), C.R.S., the Board of Health has the power to adopt local rules for regulation of on-site wastewater treatment systems (OWTS); and

WHEREAS, Larimer County Department of Health and Environment has recommended that the Board of Health adopt the revisions to the Larimer County OWTS Regulations;

NOW, THEREFORE, BE IT RESOLVED BY THE LARIMER COUNTY BOARD OF HEALTH that the Larimer County Board of Health adopts the attached revisions to the Larimer County OWTS Regulations, to become effective January 1, 2024.
