

The Colorado Victim Rights Act provides rights to any person who is victim of a criminal act, or such person's designee. Those rights include the right to:

- Be treated with fairness, respect, and dignity.
- Be free from intimidation, harassment, or abuse, throughout the criminal justice process
- Pursue a civil judgment against anyone who has committed a crime against you
- Be informed and present for all critical stages of the criminal justice process defined under the VRA.
- Provide a victim impact statement with any referral made to Community Corrections.
- Be informed of the availability of financial assistance and community services.

Community Corrections and ASD will inform you of the following critical stages:

- Referral to Community Corrections
- Arrival and projected release dates
- Notice of escape, recapture, termination, or return of custody
- Release or discharge from confinement
- Transfer to Community Supervision
- Rejection after acceptance
- Change of venue or transfer of supervision
- Request for early termination or release
- Notifications of failure to appear and any warrants or revocations resulting from the failure to appear

Victim Services

What is Community Corrections?

Community Corrections is an alternative to a prison sentence. Offenders are screened by a local Community Corrections Board and live in a controlled, residential environment in the community, leaving for work, passes, and treatment services. After successful completion of the residential phase, offenders may live at an approved location for the rest of their sentence. While on community supervision, offenders live in the community but have frequent contact with the facility through required meetings with their case manager and random drug and alcohol testing. If an offender fails to comply with the requirements of their court ordered sentence or the program rules, they can be terminated from the program and returned to court for resentencing.

What is the Alternative Sentencing Department?

The Alternative Sentencing Department includes Work Release, Midweek, Work-Enders, and Electronic Home Detention. A defendant can be sentenced to any of the above programs as an alternative to serving straight jail time. These programs allow the defendant to maintain their employment and other responsibilities, while serving their jail sentence. All offenders have access to the community but are monitored by staff. The Midweek and Work-Enders programs are unique in that they serve intermittent sentences with ASD for two-day intervals, during those two-day intervals is when the offender is supervised by staff. The remainder of the week the offender is not under ASD supervision.

Our Victim Services Specialists are here to help crime victims navigate the criminal justice system post sentencing.

Our priority is to ensure that crime victims are treated with compassion and respect. Our goal is to keep victims informed throughout the duration of an Alternative Sentencing or Community Corrections sentence.

All crime victims covered under the Victim Rights Act are automatically enrolled in the victim notification program with ASD and Community Corrections.
